

THE CONTENT SPOT SELLER POLICIES



The Content Spot is a content creation and virtual assistance marketplace where you can sell your original printable designs, digital content and services directly to bloggers around the world. In turn, your buyers have the rights to the content they purchase. They are free to give away or sell your content to their own readers or audience within their own shops.

By opening a shop on The Content Spot, you are agreeing to this policy.

All digital content must be designed by you and you must have the proper licensing for the graphics and fonts used in your content.

MARKETPLACE FEES

The Content Spot charges a 10% final value item fee after your product sells. This fee will automatically be deducted, and the remainder will be deposited into your account.

Seller earnings are currently paid out every other week on Monday. The funds should appear in your PayPal account within 48 hours of those dates.

WHAT CAN BE SOLD

- Exclusive printables created by you
- Semi-exclusive (no more than 5) printables created by you
- Exclusive recipes created by you
- Semi-exclusive (no more than 5) recipes created by you
- Exclusive graphics and memes created by you
- Photos photographed by you
- Exclusive blog posts written by you
- Exclusive round ups written by you
- Exclusive crafts or activities presented in digital format
- Semi-exclusive (no more than 5) crafts or activities presented in digital format
- Virtual assistant services
- Videos created by you

WHAT CANNOT BE SOLD

- Any items that would need to be shipped.
- Printables or graphics not created by yourself.
- Incomplete articles or roundups.
- Content that is: obscene, defamatory, harassing, or discriminatory.

REFUNDS AND DISPUTES

As a seller, you must provide great customer service and maintain a good relationship with your customers. Due to the nature of the downloadable, digital content The Content Spot as an organization does not offer refunds. We also recommend that individual sellers do not offer refunds unless it is a case of extenuating circumstances, which will be left up to the discretion of the seller. In the rare case that a seller opts to refund a customer's money, the seller is responsible for 100% of the refund. The 10% admin fee will be retained by The Content Spot.

The admins will not be responsible for disputes between sellers and customers.

TAXES AND LAWS

Please familiarize yourself with the taxes and laws of your own country, state, and locale. The Content Spot Marketplace is set up to charge taxes based on customer's address. You will be responsible for any income, sales, or local tax filings related to your personal business.

Failure to comply with these policies will result in your removal from The Content Spot Marketplace.

STEP ONE: ADD OUR EMAIL

Add our email address (hello@thecontentspot.store) to your contact list so your notifications do not end up in spam.

STEP TWO: REGISTER

Create an account on the [Vendor Registration page](#) using your name, email address and password. You'll also be asked to create your shop name and answer a few questions about your content creation.
